5. <u>STAFF REPORTS</u>

5.1 Executive Director Report

Dr. Sears reported on the progress made in the 2020 – 2024 Strategic Plan. She noted that the evaluation of annual progress over the past five years was completed. She identified that some tracking measures were redundant and that some goals were challenging due to the requirement for partnerships. She promised to provide the board with the compiled report on the Strategic Plan as soon as it became available.

5.2 Deputy Administrator's Report

Mr. Littley presented to the board that milfoil harvesting for the summer is now complete, and preparations are being made for winter milfoil management. Mr. Littley also updated the board on the possible liability of damage to a water intake pipe during milfoil treatment this summer, however insurance will cover the damages, preserving the OBWB's equipment reserve funds. Mr. Littley also provided an update on the ongoing request for proposals for a new milfoil harvester to replace the current machine, which has been operating for over 46 years.

Mr. Littley provided an update to the board on the Sewerages Facilities Assistance (SFA) program, noting that the recent SFA presentation prompted feedback regarding the loss of eligibility for local governments allowing small lot development on private sewerage treatment facilities. Following consultation with the province and local governments, Mr. Littley recommended an additional exemption to the 1.0 Hectare policy to address this concern.

5.3 Communications Director Report

Corinne Jackson reported that she had resigned on August 19th, with the resignation becoming effective on October 18th. Ms. Jackson and Board Directors and staff reflected on her 15 years at the OBWB.

In her update, she mentioned that the staff had been participating in weekly calls with the B.C. Regional Technical Drought Working Group. It was decided on August 21st to maintain the Okanagan at a Level 3 Drought, previously established on July 25, due to the ongoing analysis of precipitation and stream flow data.

Ms. Jackson provided an update to Board Directors on Make Water Work and Don't Move A Mussel outreach campaigns – noting:

- Although the Make Water Work Community Champion has been awarded, the contest for Okanagan residents will continue until September 29th.
- The final promotional videos from Habit will be delivered before her departure.
- The FireSmart campaign expressed interest in continued collaboration on WaterWise messaging into 2025.
- Signs and ads are tapering off for the Don't Move A Mussel campaign, while boat launch signs have been dispatched for delivery.

Board Directors discussed OBWB's work on communications between provinces, encouraging a western-Canadian mussel free zone – it was noted that these efforts should be sustained.

2026 Budget Preparation

I am working with RDCO accounting staff to prepare the OBWB budget for 2026 (year ending March 31, 2026). This will be presented to the Board for review and approval at the November 5 regular meeting. Per our Supplementary Letters Patent, the OBWB's final budget must be approved by the Board no later than our December 3 board meeting.

International Osoyoos Lake Board of Control Annual Meeting

The International Osoyoos Lake Board of Control will be holding its annual board meeting on Thursday, October 3rd, which I will attend as an observer. The Board will also be hosting a public meeting the same evening (October 3) in Oroville, Washington at the Oroville High School Library from 6:30 - 8:00 pm. The Board will provide an overview of the role of the International Joint Commission (IJC), present information on Okanagan and Similkameen Basin water management, including an overview of Osoyoos Lake levels for 2023-2024 (to date), and hear questions and comments from the public regarding lake level management and the Board's activities. These meetings alternate each year between Osoyoos, British Columbia, and Oroville, Washington. This year's meeting will be held in-person (in Oroville) and virtually. Milfoil Program Update

Working with the Interior Purchasing Office, we have released an RFP for the supply of a new standard milfoil harvester, with a closing date of September 25th. I anticipate reviewing proposals with milfoil staff to have a

recommendation for the board at the meeting. Timing is limited to ensure the machine is delivered by next harvesting season.

I am pleased to report that our rototilling permit for the milfoil program will be issued in the coming days, after excellent engagement with provincial staff since January. The new 5-year permit establishes a ruleset for our environmental contractor to follow for the addition of new treatment areas as needed, accounting for all known habitat and species protection, water intake protection zones, and engagement with First Nations. This new, more flexible, science-based approach will allow us to target milfoil where it is growing each year, rather than being limited to pre-defined polygons as we have been since 2013.

Invasive Mussels Update

OBWB received a response to our letter calling for interprovincial cooperation on invasive mussels from the office of MLA Grant Hunter, the head of the Alberta Invasive Mussel Task Force. MLA Hunter expressed an interest in arranging a meeting to continue the conversations started at PNWER. However, due to the timing of the B.C. election, I have suggested that we work to arrange a meeting in November or December once the election is over.

Working with Rob Birtles, Team Leader for the Drinking Water Program, and Dr. Silvina Mema, Deputy Chief Medical Health Officer, both at Interior Health, I have been invited to present at a session of the Health Officer's Council in White Rock in October. My presentation will focus on the water quality and related public health concerns caused by invasive mussels.

Quagga mussels found again in Snake River, Idaho

On September 24th I was sent a <u>news release from the Idaho State Department of Agriculture</u> that invasive quagga mussels had been detected again around the same stretch of the Snake River that was treated with 116,000 litres of Copper Chelate pesticide last fall. This finding reinforces what we have seen in several areas, that once invasive mussels are in a system, they are almost impossible to eradicate. The Snake River is a tributary to the Columbia, entering downstream of the confluence of the Okanogan River, but still in the same system as the Okanagan. While watercraft from Idaho are currently treated as "High Risk" by the province of B.C., if these mussels spread downstream, they will travel into the Columbia River entering both Oregon and Washington States.

This finding also reinforces the OBWB's and our partners' calls to action for mandatory inspections, to introduce a temporary boat ban from out of province, and to establish an invasive mussel-free zone in partnership with Alberta and Saskatchewan.

I will have more to report and recommendations at the November board meeting, following the provincial election.

Okanagan Water Stewardship Council (a technical advisory body to the OBWB)

September 12th Council Meeting

The Okanagan Water Stewardship Council meeting on September 12, 2024, included a panel discussion by subject matter experts on the threats of blue-green algae on drinking water and swimming beaches. The panel featured multiple presentations addressing water management and the challenges posed by cyanobacteria (blue-green algae) in the Okanagan. Heather Larratt's presentation highlighted Kelowna's ongoing water quality monitoring, noting significant cyanobacteria level increases in 2024 at crucial intake points, such as Poplar Point and Cedar Creek. Ed Hoppe emphasized the historical monitoring efforts since 2014 and the critical role of stormwater detention ponds in affecting cyanobacteria levels. Donovan Klassen and Stephen Horsman discussed predictive modelling of harmful algal blooms (HABs) using machine learning and satellite data. Bob Hrasko focused on water intake design, stressing the need to manage risks like forest fires and contamination. Nicolas Peleato wrapped up the panel, identifying several research opportunities at UBC Okanagan. Cyanobacteria blooms were linked to nutrient loading, particularly in Wood Lake, illustrating global and local challenges.

There are four Council Committees. The **Policy Committee** updated on revising the Okanagan Water Infrastructure Discussion Paper, incorporating feedback for the next meeting. Moreover, the committee finalized and submitted a drought report to staff for action. The **Supply and Demand Committee** reported progress on developing a proposal to model water demand, supported by recent hydrological updates. The **Building Ethical Space for Water Stewardship Committee** is working on a literature review and resource guide to be completed by the end of the term. The **Water Quality & Health Committee** continues to explore key water health issues, including an in-depth discussion on blue-green algae at the meeting.

Council members also discussed several key issues, including:

- A postdoc researcher will assess the economic impacts of water management decisions.
- Concerns about the connection between groundwater and surface water, with challenges in proving this relationship and implications for Section 88 restrictions.
- Potential impacts of a new herbicide for milfoil control on human health, agriculture, and the environment
- Continued efforts to prevent the spread of invasive mussels, emphasizing stronger watercraft controls in the Columbia River Basin.
- The launch of a new Climate Indicators dashboard to monitor environmental changes.

 Updates from Environment and Climate Change Canada and reflections on the relatively calm summer season.



Environmental Flows & Critical Flow Thresholds in Okanagan Streams

With updated hydrometric data and previous work to determine stream-specific flows for fish and ecosystems, the OBWB, in partnership with the ONA Fishery Department, is enhancing its communication tool. This tool now provides real-time hydrometric data in context with the required stream-specific fish and environmental flows. The B.C. government defines environmental flows as the quantity, timing, and quality of water flows required to sustain freshwater ecosystems and the human livelihoods and well-being that depend on these ecosystems.


Figure 1. Snapshot from the Okanagan Real-time EFN Explorer data tool (Sept 23, 2024).

Several Okanagan streams showed signs of stress in September, when water demand peaks and streamflows are critical for spawning fish (see Figure 1 below). This data underscores the urgency of addressing low summer flows and the need for reliable, real-time hydrometric data to support informed water management decisions that benefit Okanagan communities and ecosystems. The top image from the EFN Explorer highlights several streams falling below the Environmental Flow Needs, with others nearing critical thresholds. Mission Creek is shown in more detail for context.

Summary of 2024 Drought

Following a severe drought in summer 2023, the Okanagan remained at level 2 coming into the summer of 2024. The first 2024 provincial drought call for the Okanagan region was held the first week of May—several months earlier than in 2023—due to significant concerns that the below-average snowpack levels would lead to drought. Since that call on May 2nd the Okanagan has remained in drought until today.

Fortunately, despite concerns of another major drought, the Okanagan Region did not exceed level 3 due to several rain events throughout the summer. These rain events helped prevent a severe drought; however, their effect on streamflow was often brief and insufficient to take the region out of drought. This is partly due to the prolonged heatwave in July, where temperatures were consistently above 30 C and even reached the 40s. Importantly, the rain events helped refill reservoirs that had minimal recharge to their supply due to the small snowpack in the spring.




Figure 1 Weekly timeline of Provincial Drought Levels in the Okanagan for 2023 and 2024

While the region experienced a less severe drought in 2024 (Figure 1), individual streams and water supplies varied across the watershed. While Vaseux Creek has been dry at the mouth for several weeks, and flows in Shuttleworth Creek have remained very low, Equesis Creek had excellent flows all summer. Drought responses also varied, with water restrictions over the summer in only some areas. Fortunately, so far the province has not needed to implement any temporary protection orders this summer.

Although the valley is in a better position than this time last year, we are still in drought and in the late summer or early fall low-flow period. This period overlaps with a vital time for fish spawning and rearing through the watershed. Streamflows are low in many streams which is concerning for ecosystem health. Fortunately, water temperatures in the streams have been cooler the last few weeks due to cooler air temperatures allowing fish to move into streams to spawn. The irrigation period will also end soon, which will reduce water consumption in many streams.

As the drought continues, water stewardship and ongoing communication remain vital, and OBWB staff continue to participate in drought communication. Over the winter, staff will review what can be done to improve drought communication and response in the valley.

Water Conservation and Quality Improvement Grants Update

WCQI recipients for the 2024-2025 cycle are required to submit mid-term reports by October 31st. These reports will provide updates on project status and identify any areas where additional support may be necessary to ensure the projects' success. This may include reviewing progress, considering project timeline extensions, and addressing other needs.

In November the board will be asked to approve the grant process and annual theme for 2025, followed by the call for applications for the 2025-2026 WCQI grant cycle.

Sewer Grant Program - First Liquid Waste Management Plan Application Received

In June 2024, the board approved updates to the existing sewer grants program, expanding funding for community sewer systems and introducing new funds to support rural areas in protecting groundwater and community health through proper wastewater planning. As part of these updates, new funding is now available for the development of Liquid Waste Management Plans (LWMPs), which aim to protect water and community health. Communities are eligible to apply for these updated grants with payments starting as soon as 2025.

On August 22nd, we received the first LWMP grant notification from the District of Lake Country for the completion of their Liquid Waste Management Plan. This project includes drafting the Stage I/II report, the Stage III report, community engagement, and an associated Environmental Impact Study for the Okanagan Lake outfall. The notification comes a year in advance of project completion and allows OBWB to budget for new grants payable in the following fiscal year. Notifications are based on estimated project budgets and are approved in principle by the board, with the final approval being subject to an application with final numbers in the year payments commence. For the LWMP-SFA grants, the maximum eligible amount per year is \$30,000.00 for a total of 3 years (\$90,000.00).

The projected annual grant for the Lake Country LWMP project is \$17,333.33 for three years, based on 16% of the project's total cost of \$325,000.00.

Recommended motion: That the board approve in principle the Lake Country LWMP project as described above, and that staff include the projected amount in the 2026 SFA Program budget.
